RELEASE / WAIVER OF LIABILITY AND ASSUMPTION OF RISK

THE UNDERSIGNED :

- Has asked *FUN ON THE RUN, INC.* to be allowed to play paintball and acknowledges that the game involves physical exertion and other risks, known and unknown and may result in injury to the undersigned or others playing the game;
- Is aware of the possibility of risks of injury, including, but not limited to, falling, tripping, being hurt by a wild animal, snake bite, heat stroke, heart attack, hypothermia, getting lost in the wilderness, being shot by hunters, insect bites & stings, poisonous plants, improper use or operation of equipment by the undersigned or any other player and others not following the safety rules. The possibility of permanent disability or death does exist;
- Agrees to play the game according to the rules which have been explained and to follow the directions given by any game referees;
- Warrants and acknowledges that his / her physical condition is excellent and his / her mental state is sufficiently stable to enable him / her to participate safely in the game;
- Agrees to use any paintball equipment in a manner which will not cause injury or damage to himself / herself or others playing;
- Certifies that he / she is over 18 years of age or has gained permission from parent or guardian who has read and agrees to the terms and conditions of this release / waiver (also signed below);
- Authorizes use of photos, videos, name, comments, game results, etc. for promotional purposes;
- Understands and agrees to follow all safety rules and procedures;
- Understands that serious and permanent eye injury, including loss of eyesight, can occur if approved paintball safety eye wear is not worn in any area where paintball markers may be intentionally or accidentally discharged. I understand that it is my responsibility to wear approved safety eye wear and I accept that responsibility;
- Understands that the safety eye wear can fog or become dirty, and agrees that despite any, or other, such problems that he / she will keep them securely fastened to protect the eyes and will not remove while on the playing field, at the chronograph, at the target range or in any other area where he / she might be struck by a paintball, other gas powered projectile device used in paintball or by dispersing of a paint grenade;
- Understands that loss of hearing from an ear shot, disorientation and injury from a throat, groin, head or ear shot can occur if proper safety equipment is not worn to protect these areas, and understands it is his / her responsibility to wear such items.

IN CONSIDERATION of being permitted to play the game, the undersigned, on behalf of him self /her self, his / her successors, hereby releases and forever discharges *FUN ON THE RUN INC., PAINTBALL PLAYER'S SUPPLY*, d.b.a., land owners, land lease holders or managers, equipment distributors, and their successors, assigns, employees, officers, agents and franchises, dealers or operators both jointly and severally, from any and all actions, covenants, claims and demands for damages, costs, loss or injury, however arising, including negligence of *FUN ON THE RUN INC.* which may have been or may be sustained by the undersigned in any way relating to or arising out of the playing of *FUN ON THE RUN INC.* or the equipment, including but not limited to, the manufacture, selection, delivery, possession, use, or operation of the equipment or the natural environment. The undersigned desires and agrees to assume any and all risks.

THIS DOCUMENT IS INTENDED TO BE A LEGALLY BINDING CONTRACT RELIEVING THE GAME OPERATORS AND EQUIPMENT SUPPLIERS AND THEIR EMPLOYEES FROM LIABILITY FOR INJURY TO YOU. IF YOU HAVE ANY DOUBTS CONCERNING ANY ASPECT OF ITS CONTENTS, CONSULT AN ATTORNEY BEFORE SIGNING IT. THIS RELEASE OF LIABILITY AGREEMENT COVERS ALL PAINTBALL ACTIVITIES OR EVENTS I PARTICIPATE IN HEREAFTER.

I have read every item of this waiver, I understand what each item means and I agree to abide by the terms of this Waiver. This Waiver applies to any all paintball games that I participate in at or in the future.

Parent or Guardian (if participant is under 18 years of age)

1. All Players must use, ASTM Approved, Paintball Goggles at **all times in any shooting area**.
2. All Players must use a, **paintball manufactured; barrel blocking device** at all times, in Non-Shooting Areas.
3. **No shooting** into or out of the registration area, staging areas, neutral zones, parking areas or any other Non-Shooting Area.
4. **NO Alcohol or Drugs Allowed** at any time on Fun On The Run Paintball Park Grounds.
5. **Field Air & Co2 Only**, is allowed at Fun On The Run Paintball Park
6. All players must participate in a **Safety Orientation** at Fun On The Run Paintball Park
7. Any player who **destroys or damages any property** of the Fun On The Run Inc., or others will be ejected from the park.
8. Any **behavior unsuitable for this event** will be taken care of appropriately and could result in being ejected from the park
9. **Avoid field hazards**, NATURAL OR MANMADE
10. **No climbing trees, fences, walls**, or on top of any structure.
11. **No Glass** Containers
12. **No potentially dangerous gear**. The game site operator must approve all personal equipment.
13. **All players and spectators must stand at least Three feet from all netted areas**. Leaning against or standing too close to a netted area could cause injury.
14. **All markers must be chronographed** by an employee of Fun On The Run Inc. before player begins play. Players cannot adjust their marker after it has been chronographed.
15. **ALL JUDGES DECISIONS ARE FINAL**. No player will be allowed to argue with any judges or employee. The field operator will deal with any field problems or conflicts. Penalties for any infraction of safety or game rules will range from being banned from one or more games to expulsion from the park.
16. **This is not all the rules and Regulations** of Fun On The Run Paintball Park. If You have any question please ask an employee.
17. I agree and understand I must use only PPS branded paintballs at Fun On The Run Paintball Park at all times
